4. SUMMARY OF AUDIT RESULTS

4.1 Lead Auditor's Summary and Recommendation for Certification

This on-site assessment was conducted from 20th July Until 22nd July 2022. The audit programmed is included as Audit Agenda. The Estate manager, Field Supervisor and MSPO Coordinator visited and were assessed at field, office, facilities, stores and a document review were carried out in accordance with the MSPO. The subscribed MSPO management system's documentations seen with minor changes that due to internal external influenced factors that in relation to scope of certification.

During the audit process, the auditors conducted extensive interviews with the Management, members of the employees' union and committees taking place in a formal and informal environment and interviews employees were conducted.

The management was also found to constantly monitor established KPIs/objectives that significantly command the achievements of the company's corporate policy.

During the audit, several non-conformities were raised. There was 1 major non-conformity, 4 minor non-conformity and 2 observations raised during the audit. Since there were minor non-conformities, FELDA Gugusan Besout representatives have addressed a proper action plan to close the major and minor non-conformity to ensure their certification can be continued.
