**Invitation to comment on MSPO Annual Surveillance Assessment 4 (ASA 4) of
Pertubuhan Peladang Kebangsaan (NAFAS)**

Pertubuhan Peladang Kebangsaan (NAFAS) has appointed Trans Certification & Inspection Sdn. Bhd.
